# ALBANY PRESS CONFERENCE: Traveling with Dignity Act



The CP Unlimited team spent the day in Albany, New York on February 26 focused on building momentum and movement for the Traveling with Dignity Act (S.7697A / A.8373A), a bill seeking to mandate the installation of height-adjustable adult changing tables in public venues and buildings to benefit people with disabilities, veterans, seniors, and other people who use wheelchairs.

# **CP Unlimited: IT Update**

### **Connecting to CP Resources From Personal Devices**

In our efforts to strengthen security and mitigate potential data loss, we have implemented more stringent policies for accessing CP Resources from personal devices.

**To protect company data, company resources will only be allowed to be accessed from complaint devices**. You may bring your home device into compliance yourself or you may request a company device (with proper Managerial Approval) if the need to access resources from outside the office exists.

The CP IT staff will not be able to provide support or help with getting home computers compliant nor troubleshooting any personal device used. This policy applies to all applications. If, however, you wish to check your email from home, you may use the Bring Your Own Device (BYOD) option to enroll your personal phones for access to company resources.

Going forward, emails that contain Personally Identifiable Information (PII) will automatically be encrypted when leaving our secured environment.

Personally Identifiable Information can be considered but not limited to:

- Social security number
- Medical Information
- Credit Card Details
- Passport Number



Once you hit the send button on your email, the information will automatically be encrypted without the need to put "Confidential" in the subject line. The DLP policy is not limited to Outlook, but includes other Microsoft 365 services such as OneDrive, Teams, and SharePoint.
